EASY APPLICATION INSTRUCTIONS

APPLY USING A ROTARY SPREADER
RECOMMENDED SPREADER SETTING IS 60%.

STARTING FROM THE CENTER PORTION OF THE DAMAGE, spread the repellent in a circular pattern away from the damage. You will notice in 3-4 days no additional damage and may notice more activity outside the perimeter of the applied repellent. Repeat application towards the direction in which you want the skunks to exit the property.

AROUND HOMES, SHEDS & STRUCTURES: Apply a 20 inch band along the foundation so that you may visibly see the repellent.

UNDER DECKS, CRAWL SPACES & OTHER HIDDEN AREAS: Skunks may nest under hard to get areas. Put a golf ball size of Skunk Scram Professional in a small nylon or cheese cloth bag & throw under the structure. Once you feel they have vacated the area, apply outside the perimeter to keep them out.

REAPPLY Repeat in 10 days and then again in 30 to ensure they have left the area. May have to reapply after heavy rainfalls.

ALL SEASON USE! Each application of Skunk Scram Professional should last 30 days including normal rainfall or irrigation.

DO NOT USE on food or feed crops. Do not apply directly to water.
FOR OUTDOOR USE ONLY.
