**DIRECTIONS FOR USE:** For **Lawns:** Starting from the center portion of the damage, apply using a broadcast spreader at **65% open** in a circular pater away from the damage. You will notice in 3-4 days no additional damage on treated area but may notice more activity outside the perimeter of the application. Repeat application towards the direction in which you want the skunks to exit the property. **For overly damaged property,** sprinkle an extra layer using the scoop provided so that it is visible but not covering lawn. Re-apply **Skunk Scram™ Pro** in 14 days at **30% open** setting. After very heavy or extended rainfall, reapply. **NOTE: If you know where skunks are entering the property, apply a 15 foot band along the perimeter line. Be sure not to trap them inside the property with the application.** For **Applications Around Building/Structures, Under Decks/Crawl Spaces & Hidden Areas:** Apply a 20-inch band along the foundation so that you may visibly see the repellent. Skunks may nest under hard to get areas. Put a golf ball size of Skunk Scram in a small nylon bag and throw under the structure. Once you feel they have vacated the area, apply outside the perimeter to keep them out. **SEE FULL APPLICATION INSTRUCTIONS INSIDE.**
