The Florida Keys area where the endangered Miami Blue is struggling to re-colonize, the green iquana is bad news as they are threatening to drive the butterfly into extinction. Although the iguanas are too well established in Florida to be eradicated, Iguana Scram Professional can help control and exclude them on a local scale.



GENERAL APPLICATION: Flower beds, shrubs, gardens: Sprinkle or spread to form a border approx.15-18 inches out from the edge of the bed with a 20-24 inch band of Iguana Scram. Apply using the scoop provided so it is visibly heavy enough to see. Sprinkle around tree bases to keep iguana's from climbing tree to get to vegetation.

For Excessive problems in high iguana density areas: Initial Application: Apply as above and add a second band 15 inches out from the first strip around the bed and broadcast Iguana Scram Pro lightly throughout the inside of the bed. This will stop the problem and only a single band nearest the bed will be needed for maintenance applications going forward.
